NOTICE OF SECURITY INTEREST IN TRADEMARKS

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Borrower does hereby confirm the pledge and granting to Agent for its benefit and for the ratable benefit of each Lender of a continuing security interest in and to the Marks, together with the goodwill associated therewith, which security interest shall secure all the Obligations as defined in the Agreements and in accordance with the terms and provisions thereof, and authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Notice of Security Interest in Trademarks.
