RELEASE AND REASSIGNMENT OF TRADEMARKS

THIS RELEASE AND REASSIGNMENT OF TRADEMARKS dated March 6, 2009 by CIBC MELLON TRUST COMPANY, having an office at 320 Bay Street, P.O. Box 1, Toronto, Ontario, Canada M5H 4A6, as agent for the secured parties referred to in that certain Trademark Collateral Agreement hereinafter defined (said CIBC Mellon Trust Company acting as such agent being hereinafter referred to as the “*Collateral Agent*”);

WITNESSETH:

WHEREAS, the Collateral Agent and The New Republic, LLC, a Delaware limited liability company (“*Debtor*”) with its principal place of business and mailing address at 1331 H Street, NW, 7th and 8th Floor, Washington, D.C. 20005 are parties to a certain Trademark Collateral Agreement dated October 23, 2008 which was recorded in the United States Patent and Trademark Office on November 4, 2008 at Reel 003882, Frame 0256, pursuant to which Debtor granted a security interest in and collateral assignment of certain trademarks, trademark registrations and trademark applications listed on Schedule I attached hereto and certain other property (collectively, the “*Trademarks*”); and

WHEREAS, Debtor has requested that the Collateral Agent release its security interests in the Trademarks and reassign the same to Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Collateral Agent hereby releases its security interests in and collateral assignment of, and reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by the Collateral Agent, all of its right, title and interest, if any, in and to:

(i) Each trademark, trademark registration, and trademark application listed on Schedule I hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and


(ii) All proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule I hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.


This Release and Reassignment of Trademarks shall be governed by, and shall be construed and enforced in accordance with the laws of the State of New York.
