TRADEMARK ASSIGNMENT

WHEREAS, **Epitome Biosystems Inc**, a corporation of the **State of Delaware**, having a place of business at **100 Beaver Street, Waltham, Massachusetts 02453** (hereinafter, "ASSIGNOR"), is the sole and exclusive owner, free and clear of all encumbrances, of the entire right, title and interest in, to and under the Trademarks, any registrations or applications therefore as set forth on Schedule A attached hereto (Trademark Rights);

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR does hereby sell, assign, transfer and set over unto said MILLIPORE, its successors and assigns the entire right, title and interest in, to and under the trademarks and any registrations or applications therefore along with the goodwill of the business symbolized by the trademarks and any registrations or applications therefore as set forth in Schedule A; the same to be held and enjoyed by MILLIPORE for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, to the end of the term or terms for which the trademarks within said Trademark Rights are or may be registered, as fully and entirely as the same would have been held and enjoyed by ASSIGNOR, if this assignment and sale had not been made; together with all claims for damages by reason of past infringement of said Trademark Rights, with the right to sue for such damages, and collect the same for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives.

AND ASSIGNOR agrees for itself and its successors and assigns, with MILLIPORE and its successors and assigns, hereafter to execute all applications, amended specifications, deeds or other instruments, and to do all acts necessary or proper to secure the assignment and transfer to MILLIPORE and its successors and assigns of trademarks in all countries to vest and confirm in MILLIPORE and its successors and assigns, the legal title to all such Trademark Rights and to otherwise give full effect to and perfect the rights of MILLIPORE under this assignment, the same to be done without any further consideration.

AND ASSIGNOR does hereby authorize and request competent authorities to issue such trademark registrations to MILLIPORE and its successors and assigns. ASSIGNOR hereby covenants that it

has full right to convey the entire interest herein assigned, and that it has not executed, and will not execute, any agreements inconsistent herewith.
