This Assignment of Trademark is made, executed and delivered in accordance with and is subject to the representations, warranties and covenants, including all limitations thereon, set forth in the Agreement.

This Assignment of Trademark shall be binding upon Assignor and its successors and assigns and shall inure to the benefit of Assignee and its successors and assigns. The instrument shall be effective as to the transfer of the Trademark as of the Closing (as such term is defined in the Agreement).

This Assignment of Trademark shall be governed by and construed in accordance with the internal laws (as opposed to the conflicts of law provisions or rules) of the State of Delaware.
