

**FIRST AMENDMENT TO
COLLATERAL ASSIGNMENT OF TRADEMARKS (SECURITY AGREEMENT)**

This First Amendment dated February 27, 2009 is made by Rockford Corporation, an Arizona corporation ("Pledgor") and Wachovia Capital Finance Corporation (Western), a California corporation formerly known as Congress Financial Corporation (Western), as Agent ("Pledgee") with respect to that certain Collateral Assignment of Trademarks (Security Agreement) dated March 29, 2004 between Pledgor and Pledgee and recorded on April 21, 2004 at Reel/Frame 002948/0330 of the Assignment Division of the U.S. Patent and Trademark Office (the "Security Agreement").
