PARTIAL TERMINATION OF SECURITY INTEREST IN TRADEMARKS

February 5, 2009

WHEREAS, URBAN BRANDS, INC. ("UBI") had granted to Bank of America, N.A. (successor by merger to LaSalle Retail Finance, a Division of LaSalle Business Credit, LLC, as Agent for LaSalle Bank Midwest National Association f/k/a Standard Federal Bank National Association) (the "Secured Party") a security interest (the "Security Interest") in UBI's trademarks, trade names and the goodwill associated therewith (the "Trademarks") (including, without limitation, those Trademarks listed on Schedule A annexed hereto (the "Specified Trademarks")) pursuant to a certain Trademark and Trademark Applications Security Agreement (the "TM Agreement"), which was filed at the United States Patent and Trademark Office on February 28, 2005 and recorded on Reel 3050, Frame 0176;

WHEREAS, the Secured Party has agreed to release the Security Interest in the Specified Trademarks.

NOW, THEREFORE, the Secured Party releases and discharges its security interest in, and reassigns to UBI, any and all interest in the Specified Trademarks. The Secured Party agrees that, upon request of UBI or any successor-in-interest or assignee thereof, and at UBI's expense, the Secured Party will execute any document, cause to be made any filing or take any other action deemed reasonably necessary or advisable by UBI, or any successor-in-interest or assignee thereof, to effectuate the release of the Security Interest in the Specified Trademarks contemplated herein.

The TM Agreement and the Security Interest granted therein remain in full force and effect with respect to all Trademarks other than the Specified Trademarks released hereby.

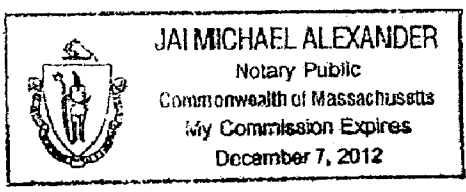
