CERTIFICATE OF CONSOLIDATION/MERGER AND CANCELLATION

This Certificate of Consolidation/Merger and Cancellation is filed pursuant to Section 61 of the Massachusetts Limited Liability Company Act, Massachusetts General Laws Chapter 156C (herein referred to as the "Act"), with respect to the merger of a domestic limited liability company into an other business entity organized under the laws of the State of Delaware, with such other business entity being the surviving entity, pursuant to Section 59 of the Act.

The Corporation agrees that, if the Corporation does not continuously maintain an agent for service of process in the Commonwealth of Massachusetts, the Corporation will appoint irrevocably the Secretary of the Commonwealth to be its true and lawful attorney upon whom all lawful process in any action or proceeding in the




