AMENDMENT TO LOAN AND SECURITY AGREEMENT

(Filing with U.S. Patent and Trademark Office)

This Amendment to Loan and Security Agreement (this "Amendment"), dated as of **February 4th, 2009**, is executed by MYPRINT CORPORATION, a California corporation ("Grantor"), having its principal place of business at:

2772 Main Street,
Irvine, California 92614  (Grantor to initial that this is correct)

and COMERICA BANK ("Bank" or "Secured Party") having an office located at 2321 Rosecrans Avenue, Suite 5000, El Segundo, California 90245, based on the following facts and understandings:

RECITALS

WHEREAS, Grantor and Bank are parties to that certain "Loan and Security Agreement (Accounts and Inventory)" dated as of December 12, 2005, which was supplemented by an "Inventory Rider" dated December 12, 2005 and an "Environmental Rider" also dated as of December 12, 2005, and which was later modified in writing from time to time (as modified, called the "Loan and Security Agreement"); and

WHEREAS, pursuant to the Loan and Security Agreement, Grantor granted to Secured Party a security interest in certain "Collateral," including all trademarks and trademark applications of Grantor; and

WHEREAS, Secured Party and Grantor wish to amend the Loan and Security Agreement to specifically refer to certain registered trademarks owned by Grantor to facilitate a filing with the United States Patent and Trademark Office ("USPTO") to put persons on notice of Secured Party's duly perfected security interest in such trademarks although Secured Party previously duly filed a UCC-1 Financing Statement with the California Secretary of State perfecting the security interest granted to Secured Party in trademarks and all other personal property of Grantor pursuant to the Loan and Security Agreement. Such UCC-1 Financing Statement was filed on January 19, 2006 with the California Secretary of State as Document No. 06-7056068705.

NOW, THEREFORE, Secured Party and Grantor agree as follows:

1. Capitalized terms used but not defined in this Amendment shall have the meanings they are stated to have in the Loan and Security Agreement.

2. The Loan and Security Agreement (and any other security agreement or third party pledge agreement executed by Grantor in favor of Secured Party) is hereby amended by supplementing the Loan and Security Agreement (or other any other security agreements and third party pledge agreements) with the attached Schedule A listing specific trademarks and

trademark registrations all as set forth in said Schedule A hereto, all of which are included in the definition of "Collateral" as that term is used in any Loan Document.

3. Grantor represents and warrants to Secured Party that all the trademarks, trademark registrations and pending trademark applications owned by Grantor or pursued by Grantor as of the execution hereof are listed on Schedule A.

4. Secured Party may record this Amendment with the USPTO at the expense of Grantor.

5. Except as herein expressly amended and supplemented, all of the terms and provisions of the Loan and Security Agreement (or other any other security agreements and third party pledge agreements) and the other Loan Documents shall continue in full force and effect and the same are hereby ratified and confirmed.





