WHEREAS the ASSIGNEE is desirous of acquiring said trademark, and the registration therefor, and the good will of the business symbolized by the trademark;

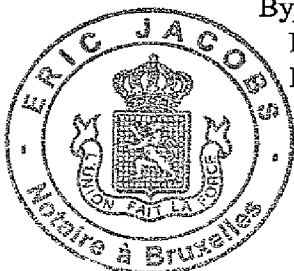


