

RELEASE OF ERRONEOUSLY FILED SECURITY INTEREST

On February 20, 1990, Congressional Quarterly, Inc., a D.C. corporation (“Registrant”) filed an application for the mark **CQ**, which registered on December 12, 1991 (Reg. No. 1669768).

On June 10, 1999, a Security Interest, executed on October 15, 1998 was filed in favor of Fleet National Bank by Candela Corporation (as assignor) and was recorded with the USPTO Assignments Branch against, *inter alia*, Trademark Reg. No. 1669768 at Reel/Frame No. 1910/0750. The filing and recordal of this Security Interest was erroneous as none of the Assignors owned the referenced trademark on October 15, 1998.

In light of the erroneous recordal of the referenced Security Interest, Registrant requests the release of such security interest and, for sake of good order, attaches a release executed by Bank of America, a successor by merger to Fleet National Bank.
