PARTIAL RELEASE OF LIEN

Solo Cup Operating Corporation, a Delaware corporation (successor by merger to Solo Cup Company, an Illinois corporation; "*Solo Cup*") has informed us that it is selling certain assets and property pursuant to an Asset Purchase Agreement, dated February 19, 2008 between Stampac USA LLC and Solo Cup attached hereto as Exhibit 1 (the "*Acquisition Agreement*").

In reference to the request of Solo Cup for a release of liens on certain assets more particularly described below, which liens were granted under a certain Security Agreement dated as of February 27, 2004 (as the same may be amended, amended and restated, supplemented or otherwise modified from time to time), among Solo Cup, as Grantor and the other Grantors party thereto and Bank of America, N.A., as Collateral Agent, the undersigned does hereby agree as follows:

1. Without recourse and without any representation or warranty of any kind, and subject to the satisfaction of the condition set forth in paragraph 2 below, Bank of America, N.A., as Collateral Agent, hereby releases any and all liens, security interests and other charges or encumbrances on (and only on) the personal property described on Exhibit 1 attached hereto listing certain asset (the "*Assets*").

2. The effectiveness of this Partial Release is subject to the condition that the sale of the Assets shall have occurred.

3. This Partial Release shall be effective only with respect to the Assets described and located on the attached Exhibit 1, and nothing contained herein shall be deemed to be a termination of any other liens, security interests or other charges or encumbrances on any other property or assets granted by Solo Cup or any of its subsidiaries in connection with, or a release of any obligations under, the Credit Agreement dated as of February 27, 2004 (as the same may be amended, amended and restated, supplemented or otherwise modified from time to time) among Solo Cup Company, a Delaware corporation, Solo Cup Investment Corporation, a Delaware corporation, the financial institutions party thereto and Bank of America, N.A., as Administrative Agent, Swing Line Lender and as an L/C Issuer, and the Loan Documents defined therein and executed in connection therewith.

All of Seller's right, title, and interest in and to all of the Acquired Assets

"Acquired Assets" means all of the following assets: (i) the machinery, equipment, manufactured and purchased parts, tools, jigs, and dies listed on Exhibit A(i) and related production manuals and warranties, (ii) all inventories of raw materials and supplies, goods in process and finished goods, of the nature identified on Exhibit A(ii) and identified pursuant to Section 2(c) of the Acquisition Agreement, excepting only inventory that, in the reasonable judgment of Buyer, is unusable, obsolete or non-saleable (subject to the limitation on such exception set forth in the last sentence of Section 2(c)(iv) of the Acquisition Agreement), (iii) the Acquired Contracts listed on Exhibit A(iii), (iv) the franchises, approvals, permits, licenses, orders, registrations, certificates, variances, and similar rights obtained from governments and governmental agencies listed on Exhibit A(iv), and (v) the trademarks listed on Exhibit A(v), provided, however, that the Acquired Assets shall not include (a) any Cash, (b) any rights to any work product produced by any artist or designer employed by the Seller, (c) any of the rights of the Seller under this Acquisition Agreement, (d) any of the tooling previously paid for by the Seller and utilized by Willey in the manufacture of products in China, or (e) any assets of the Seller not listed above.

"Acquired Contracts" means the contracts and other agreements identified in Exhibit A(iii) and include all written contracts (1) to which the Seller is a party, and (2) which are used exclusively in the operation of the Packaging Business.

"Acquired Finished Goods Inventory" means the finished goods inventory so identified and counted (together with the finished goods inventory related to Blue Bell to be purchased under the Acquisition Agreement).

"Acquired Inventory" means Acquired Finished Goods Inventory, Acquired Raw Material Inventory together with Acquired Work in Process Inventory.

"Acquired Raw Material Inventory" means inventory consisting of raw material inventory so identified and counted (together with the raw material inventory related to Blue Bell to be purchased under the Acquisition Agreement).

"Acquired Work in Process Inventory" means inventory consisting of work in process so identified and counted (together with the work in process inventory related to Blue Bell to be purchased under the Acquisition Agreement)

"Closing Date" means the closing of the transactions contemplated by this Agreement shall take place at the offices of Bell, Boyd & Lloyd LLP in Chicago, Illinois, commencing at 9:00 a.m. local time on the earlier of March 7, 2008, or the second business day following the satisfaction or waiver of all conditions to the obligations of the Parties to consummate the transactions contemplated hereby (other than conditions with respect to actions the respective Parties will take at the Closing itself), or such other date as the Parties may mutually determine.

"Packaging Business" means the Seller's paper dairy dessert and paper novelty container packaging business, as currently operated by the Seller in North America, solely with respect to the following product lines: (i) paper containers that are sold directly to dairy dessert manufacturers for filling by machine operations; and (ii) paper novelty containers that are sold directly to novelty dessert manufactures for filling by machine operations. Notwithstanding anything to the contrary in this Agreement "Packaging Business" does not include the following product lines: (i) plastic dairy dessert or plastic novelty dessert containers; (ii) juice cups; (iii) containers that are intended to be hand-filled by retail or foodservice operators and/or are sold by the Seller to retail or foodservice distributors; (iv) products in the Seller's MTrene® product line; and (v) any product lines not pertaining to dairy dessert and/or novelty dessert containers.
