## TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT dated as of January 30, 2009 is between MOSQUITO SQUAD FRANCHISE CORP., a North Carolina corporation ("Company"), and OUTDOOR LIGHTING PERSPECTIVES TECHNOLOGY CORP., a Delaware corporation ("OLPTC").

All capitalized terms not defined in this Assignment have the meanings set forth in the Assets Purchase Agreement dated as of January 30, 2009 (the "Purchase Agreement"), between Company, MOSQUITO SQUAD FRANCHISING CORPORATION, a Delaware corporation ("Purchaser"), Thomas R. Fenig, Boyd Huneycutt, Scott E. Zide and BTS Holdings, Inc.

### RECITALS


- A. Under the Purchase Agreement, Company agrees to assign to Purchaser or its Affiliates (as designated by Purchaser) certain of the Company's Intellectual Property, including without limitation the trademark MOSQUITO SQUAD (Reg. No. 3286827) (the "Mark").
- B. Company, OLPTC and Purchaser have executed an Assignment of Intellectual Property dated as of January 30, 2009, assigning Company's Intellectual Property, including without limitation the Mark, to OLPTC, a related entity of Purchaser. Company is executing this short-form assignment for recordation with the United States Patent and Trademark Office.

### ASSIGNMENT

In consideration of the promises, representations and warranties in the Purchase Agreement:

Company transfers and assigns to OLPTC all of Company's right, title and interest in and to the Mark, together with all associated good will and all related rights, all registrations and applications for registration of the Mark in the United States and any foreign countries, including any renewals and extensions of any registration that is or may be secured. The provisions of this Assignment inure to the benefit of OLPTC, its successors, assigns and other legal representatives, and are binding upon Company, its respective successors, assigns and other legal representatives.
