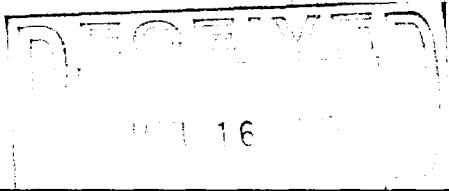


**WHEREAS**, the Assignor has agreed to assign the Trademarks to the Assignee, and the Assignee has agreed to accept said assignment.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:


1. the Assignor hereby assigns to the Assignee all of its right, title and interest in and to the Trademarks, together with the goodwill associated therewith.
