**ARTICLES OF AMENDMENT TO  
THE ARTICLES OF ORGANIZATION OF  
NOMACO K-FLEX, LLC**

Article 1 of the Articles of Organization is hereby deleted in its entirety and is replaced with the following Article 1:


“1. The name of the limited liability company is K-Flex USA L.L.C.”
