Pursuant to the provisions of Article 5.17 of the Texas Business Corporation Act (the "TBCA") and Section 2.15 of the Texas Revised Limited Partnership Act (the "TRLPA"), the undersigned converting entity, Active Organics, Inc., a Texas corporation (the "Company"), hereby certifies to and authorizes the filing with the Secretary of State of the State of Texas the following Articles of Conversion adopted for the purpose of effecting a conversion in accordance with the provisions of the TBCA and the TRLPA.

ARTICLE ONE

The Company's Plan of Conversion (the "Plan of Conversion") was duly approved and adopted by the Board of Directors and shareholders of the Company as of December 30, 2004 in accordance with the provisions of Article 5.03 of the TBCA providing for the conversion of Active Organics, Inc., a corporation incorporated under the TBCA to Active Organics, LP, a Texas limited partnership (the "Partnership").

ARTICLE TWO

An executed Plan of Conversion is on file at the principal place of business of the Company located at 1097 Yates Street, Lewisville, Texas 75057. Additionally, an executed copy of the Plan of Conversion will be on file, from and after the effective date of the Conversion (as defined below), at the principal place of business of the Partnership located at 1097 Yates Street, Lewisville, Texas 75057. A copy of the Plan of Conversion will be furnished by the Company prior to the Conversion, or by the Partnership after the Conversion, upon written request and without cost to any shareholder of the Company or any partner of the Partnership.

ARTICLE THREE

The approval of the Plan of Conversion was duly authorized by all action required by the laws under which the Company is incorporated and by its constituent documents. The number of shares of the Company outstanding at the time of such approval was 100,000 shares of common stock (the "Common Stock"), all of which shares are entitled to vote. Of the 100,000 shares of Common Stock outstanding, 100,000 shares voted for the Plan of Conversion, and no shares voted against the Plan of Conversion.

ARTICLE FOUR

Two duly executed copies of the Certificate of Limited Partnership of Active Organics, LP which is to be created pursuant to the Plan of Conversion are being filed with the Secretary of State of the State of Texas with the Articles of Conversion and are attached hereto as Exhibit "A."

ARTICLE FIVE

Pursuant to Article 5.18C of the TBCA, the Partnership will be liable for the payment of all fees and franchise taxes applicable to the Company for periods prior to the date hereof.

ARTICLE SIX

The conversion of the Company into the Partnership shall become effective on the date when the Articles of Conversion are filed with the Secretary of State of Texas (the "Effective Date").
