IN WITNESS WHEREOF this Trademark Assignment has been duly executed by an authorized officer of ASSIGNOR and is effective as of March 23, 2009.

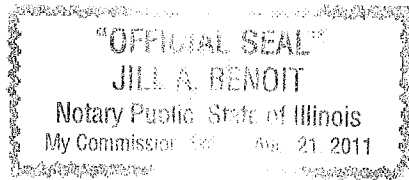
