NOW, THEREFORE, effective December 31, 2008, by this document, Assignor does hereby sell, assign, and transfer to Assignee, its successors and assigns, the entire right, title and interest in and to the Mark and any renewals thereof, in and to all good will symbolized by and associated with the business conducted under said Mark and any part thereof, and all income, royalties, damages and payments now or hereafter due or payable in respect thereto and in and to all causes of action, either in law or in equity, for past, present, or future infringement based on such Mark, and in and to all rights corresponding to the foregoing throughout the world.
