This Certificate of Conversion of Vitro America, Inc., a Delaware corporation (the "Converting Entity"), dated December 31, 2008, has been duly executed and is being filed with the Secretary of State of the State of Delaware pursuant to the provisions of Section 18-214 of the Delaware Limited Liability Company Act (the "DLLCA") and Section 266 of the General Corporation Law of the State of Delaware (the "DGCL") to convert the Converting Entity into Vitro America, LLC, a Delaware limited liability company (the "Converted Entity").

ARTICLE ONE
