## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (“**Release**”) is given as of this 20<sup>th</sup> day of March, 2009, by BANK OF AMERICA, N.A., as Administrative Agent for the Secured Parties referred to in the Security Agreement (as such term is defined herein), located at 335 Madison Ave., 5th Fl., New York, NY 10017 (“**Assignor**”), in favor of FOOT LOCKER RETAIL, INC., a New York corporation, located at 112 West 34<sup>th</sup> Street, New York, New York 10120, FOOT LOCKER ASIA, INC., a Delaware corporation, located at 112 West 34<sup>th</sup> Street, New York, New York 10120, FOOT LOCKER, INC., a New York corporation, located at 112 West 34<sup>th</sup> Street, New York, New York 10120, FOOT LOCKER SPECIALTY, INC., a New York corporation, located at 112 West 34<sup>th</sup> Street, New York, New York 10120, FL RETAIL OPERATIONS LLC, a New York limited liability company, located at 112 West 34<sup>th</sup> Street, New York, New York 10120, and EASTBAY, INC., a Wisconsin corporation located at 111 South First Avenue, Wausau, Wisconsin 54403, (collectively referred to herein as “**Assignees**”). Capitalized terms not defined herein shall have the meaning ascribed to such terms in each Trademark Security Agreement (as such term is defined herein).

WHEREAS, Foot Locker, Inc., its Subsidiaries party thereto, the banks from time to time party thereto, Bank of America, N.A., as Administrative Agent and Swingline Bank, The Bank of New York as LC Agent, Banc of America Securities LLC and J.P. Morgan Securities Inc. as Joint Lead Arrangers and Book Runners, the Syndication Agent party thereto and the Documentation Agent party thereto are parties to a Sixth Amended and Restated Credit Agreement dated as of May 16, 2008 (as amended or amended and restated from time to time, the “**Credit Agreement**”); and

WHEREAS, pursuant to the terms of a related Amended and Restated Security Agreement dated as of May 16, 2008 (as amended from time to time, the “**Security Agreement**”) among Foot Locker Inc., its Subsidiaries party thereto and Assignor, Assignees have granted to Assignor for the benefit of such Secured Parties a continuing security interest in and to the assets of Assignees specified therein, including all right, title and interest of Assignees in and to the Trademark Collateral, whether then owned or existing or thereafter acquired or arising, to secure the Secured Obligations (as defined in the Security Agreement) of Assignees;

WHEREAS, Assignor and Assignees entered into the Trademark Security Agreement, dated as of May 16, 2008, by and between Foot Locker Retail, Inc. and Bank of America, N.A., as Administrative Agent, the Trademark Security Agreement, dated as of May 16, 2008, by and between Foot Locker Asia, Inc. and Bank of America, N.A., as Administrative Agent, the Trademark Security Agreement, dated as of May 16, 2008, by and between Foot Locker, Inc. and Bank of America, N.A., as Administrative Agent, the Trademark Security Agreement, dated as of May 16, 2008, by and between Foot Locker Specialty, Inc. and Bank of America, N.A., as Administrative Agent, the Trademark Security Agreement, dated as of May 16, 2008, by and between FL Retail Operations LLC and Bank of America, N.A., as Administrative Agent, and the Trademark Security Agreement, dated as of May 16, 2008, by and between Eastbay, Inc. and Bank of America, N.A., as Administrative Agent (collectively, the “**Trademark Security**

**Agreements**”) for purposes of recording the Assignor’s security interest in the applicable trademark registries;

WHEREAS, the Trademark Security Agreements which contained schedules of U.S. registered trademarks and/or trademark applications were recorded in the United States Patent and Trademark Office on May 29, 2008, at Reel 3785/Frame 0537, Reel 3785/Frame 0891, Reel 3785/Frame 0899, Reel 3785/Frame 0873, and Reel 3785/Frame 0882;

WHEREAS, pursuant to the Security Agreement and each Trademark Security Agreement, each of Assignees granted to Assignor, to secure the Secured Obligations, a continuing security interest in all of each of Assignees’ right, title and interest in, to and under the following (all of the following items or types of property being herein collectively referred to as the **“Trademark Collateral”**), whether then owned or existing or thereafter acquired or arising:

(i) each Trademark (as defined in the Security Agreement) owned by each of Assignees, including, without limitation, each U.S. Trademark registration and application referred to in Schedule 1 hereto, and the goodwill of the business symbolized by, each Trademark;

(ii) each Trademark License (as defined in the Security Agreement), including, without limitation, each Trademark License identified in Schedule 1 hereto; and

(iii) all proceeds of, and all other profits, products, rents or receipts, in whatever form, arising from the collection, sale, lease, exchange, assignment, licensing or other disposition of, or other realization upon, any Trademark Collateral described in clauses (i) and (ii), including without limitation all claims against third parties for loss of, damage to or destruction of, or any past, present or future dilution, infringement or unauthorized use of, unfair competition with, or violation of intellectual property rights in connection with or injury to, any such collateral or for injury to the goodwill associated with any of the foregoing, in each case whether then existing or thereafter arising;

*provided* that “Trademark Collateral” did not include any United States intent-to-use trademark applications to the extent that, and solely during the period in which, the grant of a security interest therein would impair the validity or enforceability of such intent-to-use trademark applications under applicable federal law.

WHEREAS, Assignor and Assignees desire that Assignor terminate and release its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

Assignor hereby terminates, releases and discharges fully, its security interest in and to the Trademark Collateral including but not limited to the Trademarks and Trademark Licenses on Schedule 1 hereto, and reassigns and transfers any and all interest that Assignor may have in the Trademark Collateral to Assignees.



Each of Assignees hereby revokes each such Assignee's appointment, pursuant to the applicable Trademark Security Agreement, of Assignor and any officer or agent thereof as its attorney-in-fact.

Assignor hereby authorizes each of Assignees or each of Assignees' authorized representative to (i) record this Release with the United States Patent and Trademark Office, (ii) file UCC Financing Statement Amendments with the applicable filing office in order to memorialize the release of any security interest of Assignor in the Trademark Collateral, and/or (iii) otherwise file this Release in the applicable governmental office or agency.

Assignor further agrees to execute and deliver to each of Assignees any and all further documents and instruments, and do any and all further acts which each of Assignees (or such Assignee's agents or designees) reasonably requests in order to confirm this Release and each of Assignees' right, title, and interest in and to the Trademark Collateral, in each case at the Assignee's sole cost and expense.
