

**AFFIDAVIT TO CORRECT TRADEMARK ASSIGNMENT RECORDS**

1. I am Assistant Secretary of Morton International, Inc., a corporation organized and existing under the laws of Indiana, with offices at 123 North Wacker Drive, Chicago, Illinois 60606-1743.
2. Prior to May 1, 1997, a former entity Morton International, Inc., an Indiana corporation, was the owner of certain trademark applications, including those listed on the attached Schedule A (the "Trademarks").
3. On May 1, 1997, Articles of Merger were filed with the State of Indiana Office of the Secretary of State, reflecting (a) the merger of ASP Merger Sub Inc., a Delaware corporation, and Morton International, Inc., an Indiana corporation, and (b) the change of name of the surviving entity, Morton International, Inc., to Autoliv ASP, Inc., an Indiana corporation.
4. On May 21, 1997, Autoliv ASP, Inc. assigned its interest in the Trademarks to a newly formed entity, Morton International, Inc., an Indiana corporation.
5. On May 29, 1997, at Reel 1586/Frame 0394, the Assignment was recorded against the Trademarks (copy attached).
6. On June 10, 1997, at Reel 1591/Frame 0073, the Merger and Change of Name Certificate from the Secretary of State of Indiana was recorded against the Trademarks (copy attached).
7. Because the forms were submitted in the wrong order, the USPTO assignment records incorrectly identify Autoliv ASP, Inc. as the final owner of record of the Trademarks.
8. However, as reflected in the documents, Morton International, Inc. is the owner of the Trademarks.
