**DISCHARGE OF SECURITY INTEREST**  
**(Trademarks)**

**WHEREAS**, Ridley, Inc., Ridley Limited Partnership, HFI Finance LLC, Ridley U.S. Holdings Inc., Feed Rite Inc., Cotswold Holdings LLC, Hubbard Feeds Inc., PBH Transportation Company, Hubbard Feeds Management Company, Ridley Block Operations, Inc., Ridley UK Holdings Ltd., Cotswold Pig Development Company Ltd., Cotswold Pig Development GmbH, Cotswold Canada Ltd., Ridley Manitoba Limited, Ridley Nova Scotia ULC, and McCauley Brothers, Inc. (each, a “Grantor” and collectively, the “Grantors”) granted a security interest in the United States trademarks listed in Exhibits A, B, and C attached hereto and in the other collateral described in the Intellectual Property Security Agreement (collectively, the “Collateral”) to National Bank Australia Limited, in its capacity as Global Security Trustee for itself and the other Secured Finance Parties (“Global Security Trustee”), in order to secure repayment of certain amounts owing to the Secured Party (herein called the “Indebtedness”);

**WHEREAS**, an Intellectual Property Security Agreement (“Agreement”) between certain of the Grantors and the Global Security Trustee with respect to the marks listed in Exhibit A was entered into on October 16, 2001 and was recorded in the records of the United States Patent and Trademark Office (the “PTO”) on October 22, 2001, and such recordation is located on Reel 2423 at Frame 0819 of the PTO;

**WHEREAS**, certain of the Grantors granted the Global Security Trustee a security interest with respect to an additional set of marks listed in Exhibit B (“Addendum”) on or around February 7, 2006 that was recorded in the records of the PTO on February 8, 2006, and such recordation is located on Reel 3243 at Frame 0201 of the PTO; and


**WHEREAS**, a Supplement to Intellectual Property Security Agreement (“Supplement”) between certain of the Grantors and the Global Security Trustee with respect to the marks listed in Exhibit C was entered into on February 27, 2006 and was recorded in the records of the PTO on March 3, 2006, and such recordation is located on Reel 3258 at Frame 0433 of the PTO;

**NOW THEREFORE**, to all who it may concern be it known that for and in consideration of the payment to the Global Security Trustee of the full amount of the Indebtedness, the Global Security Trustee hereby (a) releases and discharges all the security interests granted by the Grantors in the Agreement, Addendum, and Supplement, being the security interests granted in respect of the trademarks—including any other trademark application(s), registration(s), or common law trademarks covered by the Agreement, Addendum, and/or Supplement—and all other Collateral and (b) acknowledges, confirms and agrees that the Agreement, Addendum, and Supplement are discharged, released and terminated and of no further force or effect.

The Global Security Trustee enters into this document solely in its capacity as security trustee under the Security Trust Deed between National Australia Bank Limited, Ridley, Inc. and others dated 28 September 2001 (“Security Trust Deed”) and that any right a person or persons may have against the Global Security Trustee under or in respect of this document are against the Global Security Trustee solely in its capacity as trustee of the trust constituted under the Security Trust Deed.




