**SECOND ARTICLES OF AMENDMENT  
TO  
THE ARTICLES OF ORGANIZATION  
OF  
GOLD CANYON CANDLES, L.L.C.**

Pursuant to A.R.S. § 29-633, Gold Canyon Candles, L.L.C., adopts these Articles of Amendment to its Articles of Organization this 1<sup>st</sup> day of October, 2007.

A. The name of the limited liability company is Gold Canyon Candles, L.L.C., (the "Company").

B. The Company's original Articles of Organization were filed with the Arizona Corporation Commission on June 16, 1997 (the "Original Articles").

C. Articles of Amendment to the Original Articles were filed with the Arizona Corporation Commission on August 11, 2005 (the "First Amendment").

D. The Original Articles, as previously amended by the First Amendment, are hereafter referred to as the "Articles."

E. The Articles shall be amended as follows:

**I.**

**FIRST:** ARTICLE I of the Articles shall be deleted in its entirety, and the following shall be inserted in its stead:

**"ARTICLE I**

**NAME:** The name of the limited liability company shall be Gold Canyon International, L.L.C."

**II.**

**SECOND:** IN ALL OTHER RESPECTS, the Articles are hereby republished and affirmed.
