**TRADEMARK ASSIGNMENT**

WHEREAS, QOL Medical, LLC, a Delaware limited liability company, with a business address of 5400 Carillon Point, Kirkland, WA 98033, ("Assignor") wishes to assign its rights, title, and interest in and to, together with the goodwill of the business associated with and symbolized by the trademarks identified on Schedule A attached hereto (the "Trademarks");

WHEREAS, Par Pharmaceutical, Inc., a Delaware corporation, with a business address of 300 Tice Boulevard, Woodcliff Lake, NJ 07677, ("Assignee") is desirous of acquiring from Assignor such rights, title, and interest in and to the Trademarks.

WHEREAS, Assignee has entered into that certain Asset Purchase Agreement with Assignor and the members of Assignor, dated as of March 31, 2009 (the "Purchase Agreement") pursuant to which Assignee has agreed to purchase from Assignor, and Assignor has agreed to transfer to Assignee, among other things, all of Assignor's right, title and interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor agrees as follows:

1. Assignor does hereby irrevocably sell, assign, transfer and set over unto Assignee, its successors and assigns, its entire right, title, and interest in and to the Trademarks, together with the goodwill of the business associated therewith and symbolized by the Trademarks, with all rights for recovery, damages and profits for past infringements, if any and Assignor further assigns to Assignee all rights to sue and receive all damages accruing from the past and future infringements of the Trademarks.

2. Assignor hereby authorizes the Deputy Commissioner of Trademark Operations, and any official of any country or countries foreign to the United States whose duty it is to issue trademarks or equivalent registrations on applications for such as aforesaid, to issue the same to Assignee, its successors, legal representatives and assigns, in accordance with the terms of this instrument and the Purchase Agreement.

3. In the event of any conflicts between this Trademark Assignment and the Purchase Agreement, the terms of the Purchase Agreement shall prevail.
