To the Secretary of State of the State of Tennessee:

Pursuant to the provisions of Section 48-21-107 of the Tennessee Business Corporation Act, as amended (the "Act"), the undersigned domestic corporations adopt the following articles of merger for the purpose of merging into a single corporation:

1. The name of the constituent corporations are State Industries, Inc., and APCOM, Inc., a wholly-owned subsidiary of State Industries, Inc. Both corporations are organized under the laws of the State of Tennessee.
2. The name of the surviving corporation is State Industries, Inc.
3. The attached Plan of Merger between State Industries, Inc., and APCOM, Inc., was duly adopted by unanimous written consent of the board of directors of State Industries, Inc., on December 9th 2003.
4. Approval of the shareholders of the constituent corporations is not required pursuant to Section 48-21-105(c) of the Act.
