**ASSIGNMENT OF TRADE NAMES,
DOMAIN NAMES AND REGISTERED TRADEMARKS**

THIS ASSIGNMENT made as of the 31 th day of March, 2009, by Compsee Incorporated, a North Carolina corporation, having an address at 400 N. Main St., Mt. Gilead, NC 27306 ("Assignor") – and – CSI Enterprises, Inc., a New Jersey corporation having an address at 10 County Line Road, Suite 25, Branchburg, NJ 08876 ("Assignee").

WHEREAS Assignor has adopted and used the trade name "Compsee" (hereinafter referred to as the "Trade Name") in connection with its barcode equipment and supplies business (the "Business"); and

WHEREAS, Assignor has registered the Uniform Resource Locators www.compsee.com, www.compseesolutionsgroup.com, and www.compseemfg.com (hereinafter referred to as the "Domain Names"); and

WHEREAS Assignor has adopted and used the trademark "COMPSEE" (hereinafter referred to as the "Trademark") in connection with the identification, promotion and advertising of the goods and services of the Business, the Trademark having been registered in the United States Patent and Trademark Office, said registration having been granted on September 15, 1981 and assigned Serial number 73/255,171 and registration number 1,169,075; and

WHEREAS Assignor is the current owner of record of the entire interest in the Trademark by assignment from McRae Industries Inc., to Assignor, said assignment having been executed on August 16, 2001, and recorded in the United States Patent and Trademark office on August 22, 2001; and

WHEREAS Assignee is acquiring the Business to which the Trade Name and Domain Names pertain; and

WHEREAS Assignee is acquiring the Business to which the Trademark pertains as required by 15 U.S.C. § 1060.

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign to Assignee:

(i) the entire interest in and to the Trade Name; and

(ii) the entire interest in and to the Domain Names; and

(iii) the entire interest in and to the Trademark and goodwill associated with the Trademark as part of the Business to which the Trademark pertains as required by 15 U.S.C. § 1060; and

(iv) any and all claims grounded upon or related to the Trade Name, Domain Names and/or Trademark whenever or wherever arising.
