## TRADEMARK ASSIGNMENT

WHEREAS, Lincoln Logs has previously assigned some of its trademarks to Assignor, as security for certain loans made by Assignor to Lincoln Logs, by Trademark Assignment dated October 7, 2003 and recorded with the United States Patent and Trademark Office (hereinafter referred to as "USPTO") on February 10, 2004.

NOW, THEREFORE, in connection with and in consideration of the foregoing, the Assignor hereby assigns and agrees as follows:

**SECTION ONE.** Grant of Security Interest. The Assignor hereby assigns, transfers and conveys all of its right, title and interest in all of its trademarks, whether registered with the USPTO or with any other entity, or arising by common law or otherwise, listed in Schedule A hereto, to Assignee.


**SECTION TWO.** Purpose. This Assignment has been executed and delivered by Assignor for the purpose of recording the conveyance with the USPTO.


