RELEASE OF TRADEMARK SECURITY AGREEMENT

This Release is executed this 8th day of APRIL 2009, by Citizens Bank of Pennsylvania, a Pennsylvania financial institution and successor of Mellon Bank, N.A., having a principal place of business at Two Mellon Bank Center, Room 200, Pittsburgh, Pennsylvania 15259 (hereinafter "Lender") to the benefit of WQED Multimedia, a Pennsylvania nonprofit corporation, previously named QED Communications, Inc., having a principal place of business at 4802 Fifth Avenue, Pittsburgh, Pennsylvania 15213 (hereinafter "WQED").

WHEREAS, on or about the 22nd day of November, 1993, WQED and Lender entered into a Security Agreement (hereinafter "Security Agreement") which secured a Loan Agreement executed of even date therewith between WQED and Lender and various other loan documents (collectively the "Loan Documents"); and

WHEREAS, all indebtedness of WQED has been fully paid and discharged, and the parties desire to release the Security Agreement, security interest and all obligations of WQED therein and to reassign the Trademarks listed in Schedule A attached hereto and incorporated herein to WQED.

NOW, THEREFORE, for and in consideration of the above premises and the mutual covenants hereinafter contained, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows, with the intent to be legally bound:

1. Release. Lender acknowledges and agrees that all Obligations of WQED to Lender (as defined in the Loan Documents between WQED and Lender of even date herewith) have been satisfied in full, and Lender hereby releases and discharges any right, title or interest it was granted under the Security Agreement in and to the Trademarks listed in Schedule A hereto, and the right and license to make, use, sell and import under the Trademarks, including without limitation all proceeds thereof (such as, by way of example, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and related foreign rights (collectively called the "Trademarks").

2. Reassignment. For good and valuable consideration, Lender hereby grants, assigns and conveys to WQED, without recourse or representation, its entire right, title and interest in and to the Trademarks. Lender shall execute and deliver to WQED all deeds, assignments and other instruments as may be necessary or proper to re-vest in WQED full title to the Trademarks upon request of WQED. Lender covenants with WQED, its successors, assigns and legal representatives that no assignment, grant mortgage, license, or other agreement affecting the rights and property herein conveyed has been made to others by Lender, and that full right to convey the same as herein expressed is possessed by Lender.

3. Binding Effect. The benefit and burdens of this Release shall inure to the benefit of and be binding upon the respective successor and permitted assigns of the parties.

4. Construction. The validity and interpretation of this Release and the rights and obligations of the parties shall be governed by the laws of the Commonwealth of Pennsylvania.
