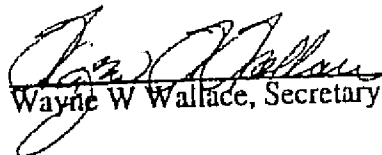
SECOND: That ARTICLE ONE of the Corporation's Articles of Incorporation is hereby amended as set forth below:

Raytheon Aircraft Company."

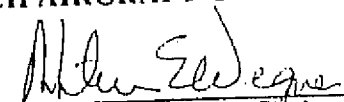

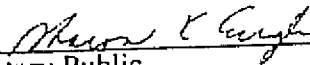

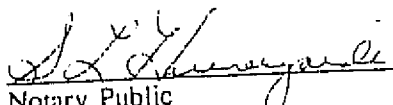
