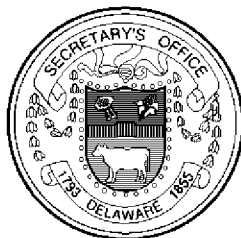

1. The name of the Corporation is "Ikano Therapeutics, Inc."
2. That a Certificate of Amendment to the Amended and Restated Certificate of Incorporation of Ikano Therapeutics, Inc., as amended, was filed with the Secretary of State of the State of Delaware on February 11, 2009 (the "Certificate") and that the Certificate requires correction as permitted by Section 103 of the General Corporation Law of the State of Delaware.
3. The inaccuracy or defect of the Certificate is: The first sentence of Article FIRST incorrectly states that the name of the corporation is "Ikano Therapeutics, Inc." The Certificate should state that name of the corporation is "Ikano Therapeutics Inc."
4. Article FIRST is inaccurate and shall be deleted in its entirety and replaced with the following:
