TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made effective as of December 19, 2008, from Chemence Medical Products, Inc., an Ohio corporation with a place of business at 185 Bluegrass Valley Parkway, Suite 100, Alpharetta, Georgia 30005 ("Chemence"), and Abbott Laboratories, an Illinois corporation with a place of business at 100 Abbott Park Road, Abbott Park, Illinois 60064 ("Abbott").

Chemence further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing , completing, or vesting in Abbott full right, title, and interest in to the Trademark.
