TERMINATION OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, the Secured Party has agreed to terminate and release the Security Interest in the Trademarks identified on Schedule A.


NOW, THEREFORE, to correct the error, the Secured Party hereby terminates and releases the Security Interest granted to the Secured Party by the Grantor in the following:
