PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of August 1, 2008 (the "Effective Date") by JPMorgan Chase Bank, N.A., as Collateral Agent (in such capacity, the "Collateral Agent"), for the benefit of the Secured Parties (as defined in the Security Agreement) (the "Grantor"), under the Security Agreement (as defined below).

WHEREAS, pursuant to a Security Agreement dated as of May 2, 2008 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") in favor of the Collateral Agent, the Grantor pledged, assigned and granted to the Collateral Agent a continuing security interest in all of its right, title and interest in and to the Collateral (as defined in the Security Agreement), including without limitation the trademark registrations and applications set forth on Schedule I hereto (collectively, the "Trademarks"), together with the goodwill associated with such Trademarks, and all Proceeds of any and all of the foregoing (other than Excluded Property);

WHEREAS, the Trademark Security Agreement dated as of May 2, 2008 (the "Trademark Security Agreement") was recorded with the Trademarks Division of the U.S. Patent & Trademark Office on May 14, 2008 at Reel 3777 and Frame 0171;


NOW, THEREFORE, in acknowledgement that certain trademarks were filed against in error, the Collateral Agent hereby terminates the Security Agreement and the Trademark Security Agreement insofar as it relates to the Trademarks, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks, together with the goodwill associated with such Trademarks, and all Proceeds of any and all of the foregoing, without warranty or recourse.

If and to the extent the Collateral Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the Grantor.

The Collateral Agent shall take all further actions, and provide to the Grantor and each of its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Grantor to more fully and effectively effectuate the purposes of this Release.
