

Assignor hereby covenants that it will execute, deliver and acknowledge to Assignee all such additional instruments, documents, conveyances or assurances and take such other action as shall be necessary, or otherwise reasonably be requested by Assignee, to more effectively evidence or record the assignment and transfer of the Mark solely at Assignee's expense.
