ASSIGNMENT OF U.S.A. TRADE-MARKS

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor does hereby sell, transfer and assign, unto Assignee all right, title and interest in and to the Trade-marks together with that part of the goodwill of the business connected with the use of and symbolized by the Trade-marks;

AND ASSIGNOR HEREBY COVENANTS AND AGREES that it will execute or procure any further necessary assurance of the title to the Trade-marks and that it will at any time upon the request and at the expense of Assignee execute and deliver any and all documents that may be necessary or desirable to perfect the Assignee's title to the Trade-marks and will at any time upon the request of Assignee, its successors, assigns or other legal representatives testify in any legal proceeding, sign all lawful documents, make all rightful oaths and generally do all lawful acts to aid Assignee, its successors, assigns or other legal representatives to obtain and enforce protection in the Trade-marks in all countries without further compensation but at the expense of Assignee, its successors, assigns or other legal representatives.
