## CONFIRMATORY TRADEMARK ASSIGNMENT

This Confirmatory Assignment, having an effective date as of June 28, 2007 (the "Effective Date"), is made by DRSI Holdings, Inc., an Ohio corporation formerly known as David Round & Son, Inc. ("Assignor"), and in favor of DRC Acquisition, Inc., an Ohio corporation ("Assignee").

*WHEREAS*, on the Effective Date Assignor sold to Assignee certain assets relating to the business of manufacturing, marketing and selling hoists, jib cranes, floor cranes, winches, tractor drives and other vertical lifting devices (the "Business"), including but not limited to all right title and interest in and to all trademarks, service marks, trade dress, trade names and brand names used by Assignor in connection with the Business; and

*WHEREAS*, the trademarks, service marks, trade dress, trade names and brand names used in the operation of the Business of Assignor included marks and names used in connection with the portion of the Business operated under the assumed name "Ruger Industries" (the "Ruger Marks"); and

*WHEREAS*, the Ruger Marks were inadvertently omitted from the schedule of transferred assets included with the trademark assignment in Assignee's favor executed by Assignor on the Effective Date; and


*WHEREAS*, Assignor acknowledges that the assets of the Business sold by Assignor to Assignee on the Effective Date included the Ruger Marks;

*NOW, THEREFORE*, Assignor confirms that on the Effective Date, Assignor sold, transferred and assigned to Assignee all worldwide right, title and interest in and to (i) the Ruger Marks, including but not limited to the marks and names set forth on Exhibit A hereto ; (ii) all registrations, and applications for registration, of the Ruger Marks worldwide; (iii) all income, royalties, damages and payments now or hereafter due or payable with respect to the Ruger Marks worldwide; (iv) all rights of action arising from the Ruger Marks worldwide, including all claims for damages by reason of past, present and future infringement of the Ruger Marks and the right to sue and collect damages for such infringement, to be held and enjoyed by Assignee for its own use and benefit and for its successors and assigns as the same would have been held

by Assignor had this assignment not been made; and (v) the goodwill of the business symbolized by the Ruger Marks.
