ASSIGNMENT OF U.S. INTELLECTUAL PROPERTY

This ASSIGNMENT OF U.S. INTELLECTUAL PROPERTY (this "Assignment"), effective the 6th day of April, 2009, is made and entered into by and between Performance Health, Inc., a Pennsylvania corporation having a place of business at 2230 Boyd Road Export, PA 15632 ("Assignor"), and Hygenic Intangible Property Holding Co., a Nevada corporation having a place of business at 1245 Home Avenue, Akron, OH 44310 ("Assignee") (each a "Party," and collectively, the "Parties").

NOW THEREFORE, in consideration of the mutual covenants and agreements set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

1. Assignment. Assignor hereby assigns to Assignee all of Assignor's right, title and interest in and to the Intellectual Property, including all rights therein provided by international conventions and treaties, and the right to sue for past, present and future infringement thereof.
2. No Warranties. Assignor makes no warranties, express or implied, with respect to the Intellectual Property.
3. Further Assurances. Assignor shall, at the cost and expense of Assignee, timely execute and deliver any additional documents and perform such additional acts necessary or desirable to record and perfect the interest of Assignee in and to the Intellectual Property, and shall not enter into any agreement in conflict with this Assignment.
4. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of New York, without regard to the conflicts of law rules of such state.
5. Counterparts. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original, and all of which together shall constitute one and the same agreement.
