ASSIGNMENT OF MARK

(Federal)

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and pursuant to the Agreement, Assignor hereby transfers, assigns, conveys and delivers to Assignee, its successors and assigns, Assignor’s right, title and interest in, to and under the Mark (including the registrations thereof and applications therefor (wherever filed)), together with the goodwill, if any, associated with the use of the Mark, free and clear of Liens (other than Clear Channel Permitted Liens).

This Assignment of Mark is made pursuant to (and does not modify) the Agreement, which contains certain representations, warranties and covenants regarding the Mark. Capitalized terms used herein and not otherwise defined shall have the respective meanings set forth in the Agreement.
