ASSIGNMENT OF MARKS

THIS ASSIGNMENT OF MARKS ("*Assignment*"), is made effective as of January 23, 2009, by and between GERMAN AMERICAN CHAMBER OF COMMERCE, INC., a New York not-for-profit corporation, with principal offices at 75 Broad Street, Floor 21, New York, NY 10004 ("*Assignor*"), and, DEUTSCHER INDUSTRIE UND HANDELSKAMMERTAG (aka The Association of German Chambers of Industry and Commerce, or DIHK), an association formed under the laws of Federal Republic of Germany, with principal offices at Breite Strasse 29, 10178 Berlin, Federal Republic of Germany ("*Assignee*").

WHEREAS, Assignor has used the marks GERMAN AMERICAN CHAMBER OF COMMERCE, DEUTSCH-AMERIKANISCHE HANDELSKAMMER, DEUTSCH-AMERIKANISCHE HANDELSKAMMER USA, DEUTSCHE AUSLANDSHANDELSKAMMERN, DE INTERNATIONAL, GACC, IHK, DIHK, and AHK, with and without their respective logos, and has licensed others to use said marks, in connection with the promotion and fostering of trade relations, and disseminating information concerning commerce and trade, between the Federal Republic of Germany and United States, and is the owner of the U.S. federal and state registrations and federal registration applications identified on Exhibit A, which is attached hereto and incorporated herein (collectively, the "*Marks*");

WHEREAS, Assignee has provided funding to Assignor in support of Assignor's promotional and other activities to foster trade relations between the Federal Republic of Germany and the United States and related activities and has coordinated such activities by Assignor with the similar activities of Assignor's two sister chambers, namely, GERMAN AMERICAN CHAMBER OF COMMERCE OF THE MIDWEST, INC. and GERMAN AMERICAN CHAMBER OF COMMERCE OF THE SOUTHERN UNITED STATES, INC.; and

WHEREAS, Assignor desires to assign to Assignee, and Assignee agrees to receive from Assignor, all of Assignor's rights, title and interest in and to the Marks pursuant to the terms and provisions set forth herein;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby accepted and acknowledged, the parties agree as follows:

1. Assignor hereby transfers, conveys, assigns, delivers and quit claims to Assignee, and Assignee hereby accepts from Assignor the transfer, conveyance, assignment, delivery and quit claim of, all of Assignor's rights, title, and interest in and to the Marks in the United States, together with the goodwill of the business symbolized by and appurtenant to said Marks, as well as all of Assignor's rights to bring an action, whether at law or in equity, against any third party for infringement or other misuse of any of the Marks, including the right to bring an action for past, present and future infringement or misuse, and all rights to recover damages, profits and injunctive relief for infringement or misuse.


2. Assignor also agrees to take all further actions, and to execute any and all further documents and instruments, that Assignee may reasonably request to confirm and effectuate this Assignment.

3. This Assignment shall be governed by and construed in accordance with the laws of the District of Columbia without regard to its conflicts of law principles.


4. This Assignment may be executed in one or more counterparts, each of which when so executed and delivered shall be an original, but all such counterparts together shall constitute one and the same instrument.


