TRADEMARK ASSIGNMENT

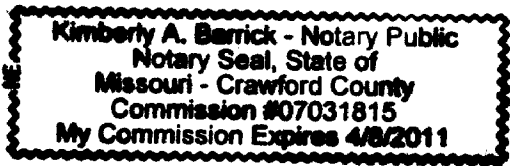


