**RELEASE OF SECURITY INTERESTS**

**WHEREAS**, pursuant to the Trademark Collateral Assignment and Security Agreement (“**Security Agreement**”) entered into on January 4, 2006 among WESTERN ORGANICS, INC., an Arizona corporation (“**Western Organics**”), BENICK BRANDS CP, LLC (“**Benick Brands CP**”), and TD BANK, N.A., formerly known as TD BANKNORTH, N.A., a national banking association, (“**TD Bank**”), Western Organics and Benick Brands CP granted a security interest to TD Bank in certain Pledged Trademarks (as defined in the Security Agreement), , including all other forms of collateral identified in the Security Agreement (collectively the “**Secured Property**”); and

**WHEREAS**, such Security Agreement was recorded within the records of the United States Patent and Trademark Office at reel 3291, frame 0710; and


**WHEREAS**, all of the obligations arising in connection with the grant of the security interest have now been satisfied and TD Bank desires to formally release its security interest and all right, title and interest of TD Bank in and to the Secured Property.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, TD Bank does hereby release and forever discharge and reconvey to Western Organics and Benick Brands CP all of TD Bank’s security interest in Western Organics and Benick Brands CP’s right, title, and interest in, to and under the Secured Property, including TD Bank’s security interest in the trademark registrations identified on Schedule A, attached hereto, so that it is as if the security interest had never been granted by Western Organics and Benick Brands CP; and TD Bank does further acknowledge and affirm that all of the rights and remedies of TD Bank with respect to the security interest concerning the Secured Property have been and are hereby extinguished; and TD Bank further agrees to perform all additional acts necessary (including executing additional documents) to confirm that TD Bank has no interests of any type in, to, or under the Secured Property.

IN WITNESS WHEREOF, TD Bank has caused this RELEASE OF SECURITY INTERESTS to be executed and delivered as of the 16<sup>th</sup> day of June, 2008.
