**ASSIGNMENT OF TRADEMARK AND**

Assignor hereby agrees that Assignee shall have the right to record this instrument of assignment in the United States Patent and Trademark Office, so as to establish Assignee as owner of record of the Registration.


Assignor further agrees, at the request of Assignee and without charge or cost to Assignee, to (i) execute and have executed any and all other documents of any kind whatsoever, and to provide whatever information may be required, to carry out the terms and intent of this Assignment; and (ii) fully cooperate with Assignee, as reasonably

required, to enable Assignee to duly record this instrument of assignment with the United States Patent and Trademark Office, so the Assignee's ownership of the Registration is duly made of record.
