**RELEASE OF TRADEMARK SECURITY INTEREST**

THIS RELEASE OF TRADEMARK SECURITY INTEREST ("Release") is made effective as of April 3, 2009 by JPMORGAN CHASE BANK, N.A., (the "Administrative Agent") to HARDINGE, INC., (the "Borrower"), as follows:

WHEREAS, on June 13, 2008, the Borrower and the Administrative Agent entered into a Pledge and Security Agreement ("Security Agreement) and a Confirmatory Grant of Security Interest in United States Trademarks ("Confirmatory Grant");
