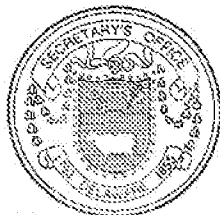

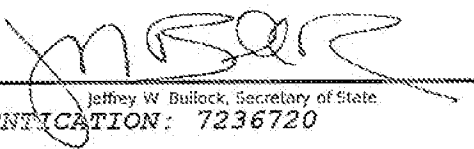

PURSUANT TO THE DELAWARE GENERAL CORPORATION LAW**

First Lady International Corporation, a corporation organized and existing under the laws of the State of Delaware (the "Corporation"), does hereby certify that:

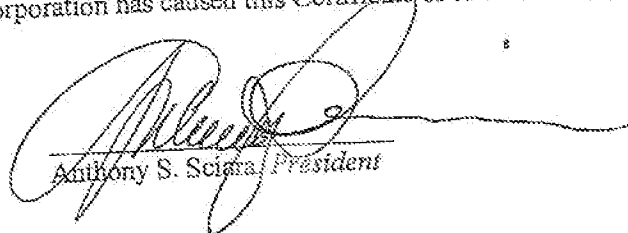
FIRST. The Certificate of Incorporation is hereby amended in order to change the name of the Corporation. To accomplish the foregoing amendment, Article FIRST is stricken out in its entirety, and the new Article FIRST is substituted in lieu thereof as follows:

"FIRST: The name of the Corporation is New Image Labs Corporation."

SECOND. The foregoing Amendment to the Certificate of Incorporation of the Corporation was duly authorized pursuant to Sections 141(f) and 242 of the Delaware Corporation Law by the Joint Written Consent In Lieu of Special Meeting of the Sole Director and Sole Shareholder of the Corporation dated March 31, 2009.

THIRD. This Certificate of Amendment to the Certificate of Incorporation shall be effective upon the filing of same with the Secretary of State of Delaware.
