**CERTIFICATE OF AMENDMENT

CERTIFICATE OF INCORPORATION

Good Health Natural Foods, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), hereby certifies as follows:

FIRST: That the Board of Directors of the Corporation, by written consent in lieu of a meeting, adopted a resolution setting forth a proposed amendment of the Certificate of Incorporation, as previously amended by the Certificate of Merger filed with the Delaware Secretary of State on December 20, 2005, declared the amendment to be advisable and submitted the resolution to common stockholders of the Corporation for consideration and approval. The resolution setting forth the proposed amendment is as follows:

RESOLVED, that the Certificate of Incorporation be amended by changing the Article thereof numbered "1" so that, as amended, said Article shall be and read as follows:


"1. Name. The name of the Corporation is **GOOD HEALTH NATURAL PRODUCTS, INC.**"

SECOND: That thereafter, pursuant to resolution of its Board of Directors, the common stockholders of the Corporation, by written consent in lieu of a meeting in accordance with the provisions of Section 228 of the General Corporation Law of the State of Delaware, approved the amendment to the Certificate of Incorporation.

THIRD: That the amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.

FOURTH: That the capital of said Corporation shall not be reduced under or by reason of said amendment.
