**ASSIGNMENT OF INTELLECTUAL PROPERTY**

This ASSIGNMENT OF INTELLECTUAL PROPERTY (this "Assignment"), dated as of March 10, 2004, is made by and between Ruger Industries, Inc., an Ohio corporation ("Assignor") and David Round & Sons, Inc., an Ohio corporation ("Assignee").

**WITNESSETH**

WHEREAS, Assignor and Assignee are parties to that certain Asset Purchase Agreement (the "Asset Purchase Agreement") of even date herewith pursuant to which, among other things, Assignor has agreed to sell to Assignee certain of the assets used by Assignor to conduct Assignor's business (the "Business"); and

WHEREAS, Assignor desires to assign to Assignee all of Assignor's right, title and interest in and to Assignor's intellectual property rights (the "Intellectual Property Rights") identified on Schedule A attached hereto and made a part hereof.


NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

1. Assignor does hereby sell, transfer, assign and set over unto Assignee all of Assignor's worldwide right, title and interest in and to the Intellectual Property Rights, including, but not limited, the goodwill of the Business connected with the use thereof, and symbolized thereby, free and clear of any and all liens.
2. Assignor, at Assignee's request, will promptly execute and/or deliver to Assignee all additional documents reasonably necessary to effect the transfer of the Intellectual Property Rights from Assignor to Assignee and to record said transfer in the appropriate records and registries.
3. This Assignment will be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
4. This Assignment may be executed and delivered in any number of counterparts, each of which so executed and delivered shall be deemed to be an original and all of which shall constitute one and the same instrument and shall be governed by, and construed in accordance with, the rules and substantive laws of the State of Ohio.

IN WITNESS WHEREOF, Assignor and Assignee have caused this Assignment to be signed as of the date first written above.


