**FIRST LIEN TRADEMARK SECURITY AGREEMENT**

FIRST LIEN TRADEMARK SECURITY AGREEMENT, dated as of the 30<sup>th</sup> day of March, 2009, by Quintiles Transnational Corp., a North Carolina corporation (the "Borrower"), and Eidetics, Inc., a North Carolina corporation ("Eidetics" and, together with the Borrower, the "Grantors"), in favor of Citicorp North America, Inc., in its capacity as collateral agent pursuant to the Credit Agreement (as defined in the Security Agreement, defined below), as pledgee, assignee and secured party (in such capacities and together with any successors in such capacities, the "Collateral Agent").

WHEREAS, each of the Grantors has, pursuant to that certain first lien security agreement dated as of March 31, 2006 (as supplemented from time to time, the "Security Agreement"; capitalized terms used but not defined herein having the meaning assigned to such term in the Security Agreement), granted to the Collateral Agent for the benefit of the Secured Parties a security interest in and to all of the right, title and interest of such Grantor, in, to and under the Collateral, including with respect thereto, the Trademarks, as collateral security for the payment and performance in full when due of the Secured Obligations; and


WHEREAS, each of the Grantors and the Collateral Agent wish to further memorialize the security interest described above as it relates to the registered and pending U.S. federal Trademarks identified in Schedule A, attached hereto, and incorporated herein by this reference, and the goodwill attendant thereto and all other rights appurtenant thereto, including but not limited to all products and proceeds thereof;

NOW THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, each of the Grantors hereby grants unto the Collateral Agent a security interest in and lien on all of its right, title and interest in the Trademarks identified in Schedule A, as collateral security for the payment and performance in full when due of the Secured Obligations.



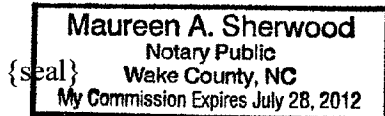

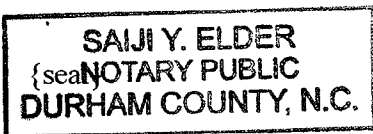
