RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of April 17, 2009, by Wells Fargo Retail Finance, LLC, as administrative agent and collateral agent ("Agent"), in connection with the Loan and Security Agreement, dated as of June 24, 2008 (together with the documents entered into connection therewith, the "Financing Documents"), by and among Schurman Fine Papers, d/b/a Papyrus, a California corporation (the "Company"), the other Borrowers named therein, the Revolving Credit Lenders named therein and Agent.

WHEREAS, in connection with the Financing Documents, each of the Company, Brenda Walton and Jeanene Marie Scott (collectively, the "Grantors"), granted a security interest in its copyrights and trademarks listed on Exhibit A attached hereto and all extensions, renewals, reissues, divisions, continuations and continuations-in-part of any of such property listed on Exhibit A (collectively, the "IP Collateral"); and


WHEREAS, the Grantors, pursuant to the Purchase and Sale Agreement, dated as of the date hereof, the Grantors have sold, assigned, transferred, conveyed and delivered the IP Collateral to ACG, LLC, and Agent hereby terminates, releases and discharges the security interest granted to Agent in the IP Collateral under the Financing Documents, and the parties wish to record with the U.S. Patent and Trademark Office and the U.S. Copyright Office the release of the security interest against the IP Collateral.

NOW, THEREFORE, for good and valuable consideration, Agent does hereby terminate, release and discharge the security interest, liens, and all other rights it may have in the IP Collateral granted to it by the Grantors pursuant to the Financing Documents and any right, title or interest of Agent in such IP Collateral does hereby cease and become void, all of which was recorded in the United States Patent and Trademark Office or the United States Copyright Office, as applicable. This Release of Security Interest in Intellectual Property shall not be effective to release any security interest in any of the IP Collateral granted to the Company by American Greetings Corporation or any assignment thereby by the Company to Agent.
