**Trademark Assignment**

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and delivered by **BROWN & COLE, INC.**, a Washington corporation ("Assignor"), in favor of **THE MARKETS, LLC**, a Washington limited liability company which was formerly known as Brown & Cole Stores, LLC ("Assignee").

RECITALS

A. Assignor is the owner of the following trademark (the "Mark"):

<b>Mark</b>	NORTHWEST CHOICE
<b>Goods and Services</b>	Class 029. G & S: meats excluding fresh and processed turkey; fish; milk; and eggs. Class 030. G & S: coffees and bakery goods.

B. Pursuant to a Contribution Agreement dated as of August 8, 2001 by and among Assignor, Assignee, Ennen Food Stores, Inc. and Associated Grocers, Incorporated (the "Agreement"), Assignor agreed to assign the Mark, together with the goodwill associated with the Mark, to Assignee.

C. A previous omnibus trademark assignment of various trademarks filed with the United States Patent and Trademark Office intended to include the Mark among the assigned marks, but it does not appear that the assignment was recorded as intended, possibly because of a divisional request filed in the trademark application at about the same time. Assignee has undergone a name change since that time. Assignee has accepted and continuously used the Mark in commerce in accordance with the intent of the Agreement.

D. This is a nunc pro tunc assignment for purposes of correcting the records of the United States Patent and Trademark Office.


THEREFORE, for good and valuable consideration, and in addition to such other instruments of transfer as Assignor has granted in favor of Assignee in connection with the closing of the transactions contemplated by the Agreement, Assignor hereby transfers, conveys and assigns to Assignee and its successors in interest the entire right, title and interest of Assignor in and to the Mark, including without limitation the goodwill associated with the Mark, and Registration No. 2,724,794 issued by the United States Patent and Trademark Office.

This Assignment is given pursuant to the Agreement and shall be construed consistently therewith. Nothing contained in this Assignment is intended to or shall be deemed to amend, supersede, enlarge or modify any of the obligations, agreements, covenants, representations or warranties of Assignor or Assignee under the Agreement, all of which shall survive the execution and delivery of this Assignment.
