TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "**Agreement**") dated as of August 1, 2005, by and between Public Media, Inc., a Delaware corporation, having its principal office at 4423 North Ravenswood, Chicago, IL 60640, ("**Assignor**"), and Image Entertainment, Inc., a California corporation, having its principal office at 20525 Nordhoff Street, Suite 200, Chatsworth, California 91311 ("**Assignee**").

WHEREAS, Assignor is the owner of all right, title and interest in and to the trademark HVE *Stylized*, registered with the United States Patent and Trademark Office (Registration No. 3,000,209) for use in connection with "prerecorded cinematographic movie film, videocassettes, digital video discs, and DVD-ROMS, all featuring entertainment themes in the fields of music, drama, comedy, television, education, fine arts, action and documentary" (International Class 9) and "wholesale and retail distributorship featuring motion pictures and television programming and documentaries via videocassettes, digital videodiscs, and DVD-ROMs for individual use and for use in broadcast and theatrical exhibition" (International Class 35) (the "**Trademark**"); and


WHEREAS, Assignor desires to assign its entire right, title and interest in and to the Trademark to Assignee, and Assignee desires to acquire the exclusive right, title and interest in and to the Trademark.

1. Assignor hereby assigns to the Assignee, its successors and assigns, all right, title and interest in and to the Trademark as Assignor may possess, together with the goodwill symbolized by the Trademark, all common law rights relating thereto, and all rights to bring action on and recover damages for past, present and future claims, demands and causes of action based thereon, if any.
2. Assignor agrees to reasonably assist Assignee, its successors or assigns, to secure Assignee's rights in the Trademark, including but not limited to the execution of any and all documents which Assignee shall deem necessary in order to convey to Assignee, its successors and assigns, all right, title and interest in and to the Trademark.
3. This Agreement shall be binding upon Assignor's heirs, successors and assigns and will be for the benefit of Assignee, its successors and assigns.


