ARTICLES OF AMENDMENT TO THE
CHARTER OF
PEOPLETECH, INC.

Pursuant to the provisions of Section 48-20-106 of the Tennessee Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment (the "Articles of Amendment") to its Charter (the "Charter"):

1. Name of Corporation. The name of the Corporation is PeopleTech, Inc.
2. Section 1 of the Charter is hereby deleted in its entirety and replaced with the following:
 - "1. The name of the corporation is Ovation, Inc."
3. Section 9 of the Charter is hereby deleted in its entirety and replaced with the following:
 - "9. The corporation shall not have a board of directors. The corporation shall be managed by the shareholders of the corporation rather than by a board of directors."
4. Except as amended by these Articles of Amendment, the Charter of the Corporation shall remain in full force and effect.
5. Adoption. These Articles of Amendment were duly adopted by the Corporation's sole shareholder on October 9, 2008.
6. Effective Date. These Articles of Amendment will be effective when filed with the Secretary of State.
